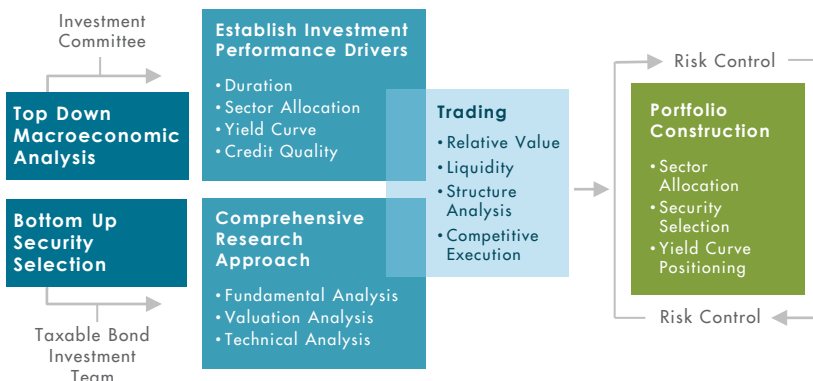

The Strategy buys only investment grade securities and maintains a similar risk profile to that of the Bloomberg Intermediate Aggregate Index. The Intermediate Taxable Bond Composite (composite) includes all portfolios invested in the Intermediate Taxable Bond Strategy with a minimum market value of \$100,000. Prior to September 30, 2019 the composite included accounts invested in the Core Bond Strategy with restrictions preventing the purchase of bonds with maturities greater than 15 years. The composite was created on August 31, 2019. The Intermediate Taxable Bond segments of multi-asset portfolios are included in the composite. Each segment of multi-asset portfolios is managed with its own cash account. Accounts are included in the composite after two full months under management. Closed accounts are included through the last full month under management. Inception date is December 1, 2010.

All results reflect the reinvestment of dividends and income, and factor in commission costs. Performance is expressed in US dollars. Composite portfolio income may be net or gross of withholding tax depending on the accounting methodology of the custodian bank. The performance results presented may not equal the rate of return experienced by any particular GW&K portfolio due to various reasons, including differences in brokerage commissions, fees, client contributions or withdrawals, position size in relation to account size, diversification among securities and market conditions. The three-year annualized standard deviation measures the variability of the composite and the benchmark returns over the preceding 36-month period. Gross returns are used for the composite calculation. The standard deviation measure is presented annually, for periods where 36 monthly returns are available.

The firm uses an asset-weighted standard deviation calculation to measure dispersion, which is reported on a yearly basis. Dispersion is used to measure the volatility of gross portfolio returns within the composite. Only portfolios that have been included in the composite for the full year are included in the dispersion calculation. Where dispersion is listed as N/A, the information is not statistically meaningful due to an insufficient number of portfolios in the composite for the entire year. Net of fee returns are based on a maximum fee of 0.65% per year, applied monthly. This fee consists of an investment management fee of 0.15% per year and a wealth advisory fee of 0.50% per year. Client fees may vary.

The performance shown is compared to the Bloomberg Intermediate Aggregate Index. The Bloomberg Intermediate Aggregate Bond Index covers the US investment grade fixed rate bond market. It is comprised of securities from Bloomberg Government/Corporate Bond Index, Mortgage-Backed Securities Index and the Asset-Backed Securities Index with maturities from one to ten years.
