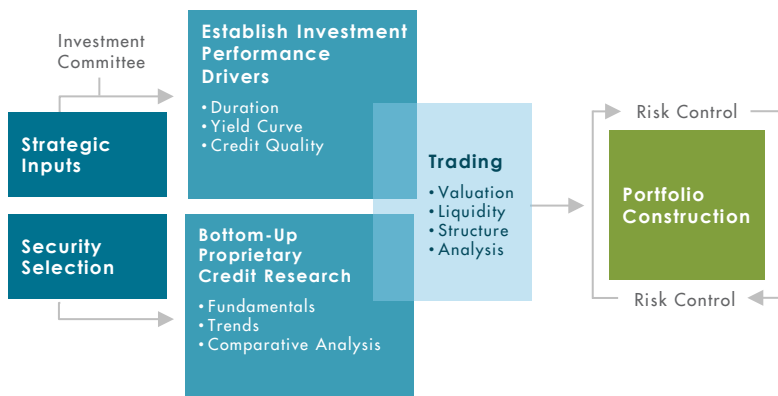

The Municipal Bond Plus Strategy combines our flagship municipal bond strategy and our higher yielding, longer duration completion fund. The Strategy is appropriate for total return orientated clients who are seeking more income and are comfortable with incrementally higher volatility. Our baseline is 80% Municipal Bond Strategy/20% "Plus", however the allocation is customizable based on individual objectives and risk tolerances. The Municipal Bond Plus Composite (composite) includes all portfolios invested in the Municipal Bond Plus Strategy with a minimum market value of \$250,000. The composite was created on August 1, 2010. Accounts are included in the composite after four full months under management. Closed accounts are included through the last full month under management. Effective November 1, 2020, portfolios are removed from the composite in the month a significant cash flow, defined as an inflow of non-standard investments greater than 10% of the portfolio value or greater than or equal to a monthly total of \$100,000, occurs. Additional details on this policy are available upon request. Inception date is August 1, 2010.

All results reflect the reinvestment of dividends and income, and factor in commission costs. Performance is expressed in US dollars. Composite portfolio income may be net or gross of withholding tax depending on the accounting methodology of the custodian bank. The three-year annualized standard deviation measures the variability of the composite and the benchmark returns over the preceding 36-month period. Gross returns are used for the composite calculation. The standard deviation measure is presented annually, for periods where 36 monthly returns are available.

The firm uses an asset-weighted standard deviation calculation to measure dispersion, which is reported on a yearly basis. Dispersion is used to measure the volatility of gross portfolio returns within the composite. Only portfolios that have been included in the composite for the full year are included in the dispersion calculation. Where dispersion is listed as N/A, the information is not statistically meaningful due to an insufficient number of portfolios in the composite for the entire year. Net of fee returns are based on a maximum fee of 0.85% per year, applied monthly. This fee consists of an investment management fee of 0.35% per year and a wealth advisory fee of 0.50% per year. Client fees may vary.

The performance shown is compared to the Bloomberg 10-Year Municipal Bond Index. The Bloomberg 10-Year Municipal Bond Index is comprised of investment grade national municipal bond issues with a maturity range of 8–12 years.
